General terms and Conditions:

- 1. Duration of MOU: This MOU will be effective from the date of agreement and will have an initial duration of 7 (seven) years. The MOU may be extended with the consent of both the parties.
- 2. Confidentiality: Both the colleges will maintain confidentiality about the terms and conditions of the agreement.
- 3. Termination of MOU: This MOU may be terminated at any time with a 15 days prior notice from either of the parties.
- 4. Modification: Any alteration / modification to the MOU may be done with mutual consent of both the parties. Involvement of new departments/activities may be done from time to time with mutual consent of both the colleges.
